Our 10 jurisdictions span a variety of natural wonders, abundant resources, and economic opportunities, each distinct in their own right. The Summit is a wonderful gathering of all that the region has to offer, and with our collective voices we have the chance to greatly impact the way we approach our shared challenges. Your contributions at the Summit are invaluable and essential to PNWER's mission to improve understanding, growth and cooperation across the binational region. With this collaborative spirit, please take the opportunity to build relationships, share your experiences, and learn from others.

I would also like to welcome participants from the Pacific NorthWest Disaster Resilience Symposium and the Columbia River Treaty Symposium, both held in conjunction with the PNWER Annual Summit this year. The Pacific NorthWest Disaster Resilience Symposium, designed by PNWER's Center for Regional Disaster Resilience, will host leaders and decisions makers in election infrastructure and cyber security to address common issues, examine solutions, and promote information sharing. The Columbia River Treaty Symposium brings together federal, state, local, tribal leaders, public policy leaders, academics, private partners and various stakeholders of the Columbia River to discuss the benefits and impacts of the River on our region. This three part symposium was only made possible by the collective efforts of our leadership in British Columbia and the states of Montana, Idaho, Washington, and Oregon. The success of this Symposium truly embodies the regional partnerships that thrive throughout the PNWER jurisdictions.

It has been an absolute honor serving this past year as PNWER President. These are a few of our accomplishments:

Trade: The PNWER NAFTA Modernization Task Force created a survey to gather feedback across North America, and communicated recommendations to Parliament, the USTR, and members of Congress. PNWER consulted with state and provincial leadership, and just hours after the proposed U.S. tariff announcement, sent a strong message to the White House that Canada should be exempt from the steel and aluminum tariffs, and that tariffs are not the way to address trade imbalances.

Energy: The Legislative Energy Horizon Institute, PNWER's annual 60 hour certificate program in energy policy, has graduated over 200 MLAs and legislators to date. 40 legislators, including MLAs from Saskatchewan and British Columbia, will participate in the Institute this July in Richland, Washington, and November in DC.

Invasive Species: PNWER was instrumental in securing \$14 million in federal funds for the fight against invasive species for Washington, Idaho, Oregon, and Montana over the past 3 years. These mussels would have a devastating impact on the agriculture and hydropower sectors. PNWER has pushed Canadian federal agencies to support provincial efforts and is collaborating with the provinces on an Invasive Mussel Prevention Framework for Western Canada.

Cybersecurity: PNWER's Center for Regional Disaster Resilience procured independent funding from DHS to develop a cyber resilience assessment tool and also a cyber response planning guide for businesses and local governments in the region.

We hope you will find this year's Summit agenda to be engaging and thought provoking, and we are excited to be continuing our discussions in Spokane. I would like to personally invite you to the 2018 Economic Leadership forum this November 13-15, in Whitehorse, Yukon, and next year's 29th Annual Summit in Saskatoon, Saskatchewan from July 21-25, 2019.

Thank you for coming to the Summit, and for your continuous effort in making the Pacific Northwest a region that we are proud to call home.

NAFTA MODERNIZATION TASK FORCE

In November 2016, PNWER established a NAFTA Modernization Task Force to work toward developing a regional bi-national consensus of recommendations to update the agreement. The Task Force held monthly calls with the goal of discussing key areas of interest to include in a modernized agreement and to develop a survey to reach out to the economic sectors across the binational region. With NAFTA renegotiation ongoing, PNWER provides regular updates on the renegotiation process.

NAFTA Modernization Survey

Through this process PNWER created a survey to gather feedback from across North America. The survey collected data from industries and organizations on overarching principles that they would like to see included in a renegotiated NAFTA agreement. The results of the survey were submitted to the United States Trade Representative and Canadian Parliament House Standing Committee on International Trade respectively in response to their calls for public comment. PNWER also testified at hearings at the US Dept. of Commerce and Standing Committee on International Trade in Ottawa.

NAFTA Modernization Resolution

In November 2017 the PNWER Board approved a resolution in support of the modernization of NAFTA. In summary, the resolution states that the PNWER supports the modernization of NAFTA to enhance the existing economic relationships within PNWER jurisdictions in a mutually beneficial manner; and, that PNWER continues to encourage our countries to respect the spirit of NAFTA by promoting policies that support and enhance the integrated nature of our supply chains and economies that provide jobs in our respective communities; and that PNWER supports improvements that enhance the commitment and the success for all parties of NAFTA; and that PNWER members encourage their federal governments to strive towards a modernized NAFTA that builds upon its current success to further enhance trade and investment in North America.

Statement on Tariffs

In 2018 the PNWER Executive Committee wrote to President Trump and Secretary Ross and released several statements in favor of exempting Canada from Steel and Aluminum Tariffs. Likewise, PNWER issued a statement opposing tariffs on wood coated paper products. The PNWER Executive Committee recognizes this cross border region works closely together every day with our interconnected and interdependent supply chains, and dozens of cross border cooperative agreements on everything from our shared transboundary watersheds, cross border airsheds, climate action, cross border law enforcement, invasive species prevention, forest fires prevention, to defending our shared borders in the 60 year old NORAD (North American Air Defense) System. Protectionism will seriously damage the vital economic regional partnership in both of our countries.



A partnership has been formed with the Northeastern University's Global Resilience Institute (GRI). CRDR staff contributed to a GRI study on the impact of wildland fires on critical infrastructures. Work on earthquake resilience that began with a GRI-led Critical Infrastructure Workshop in September, will continue in 2018. The CRDR will plan and execute a Blue Cascades, Earthquake Recovery Tabletop Exercise for King County, Washington focused on critical infrastructure interdependencies.

Cybersecurity



Cybersecurity has remained an area of emphasis with two workshops in Washington State and one in Idaho. Topics included communication sharing and cyber insurance.

2018: Maritime & Drones Resilience Challenge

CRDR has been awarded two Department of Homeland Security Resilience Challenge infrastructure projects. The first project will develop a maritime cybersecurity reporting Concept of Operations (CONOPS) that can be used by the maritime industry to report cybersecurity incidents and share information with key partners.

The second grant, in partnership with the Global Resilience Institute, will develop technologies to use Unmanned Aircraft Systems (UAS), or drones, to inspect critical infrastructures post disaster. GRI will provide the technical expertise to execute the engineering aspects of the project and the CRDR will assist with overall stakeholder coordination and grant administration.

LEGISLATIVE ENERGY HORIZON INSTITUTE

The Legislative Energy Horizon Institute (LEHI) is a certificate program covering the North American energy system. LEHI is specifically designed to prepare emerging state and provincial leaders to address the complex energy issues facing state and provincial legislatures.

A former Canadian diplomat, Colin Robertson is Vice President and Fellow at the Canadian Global Affairs Institute. Prior to joining Dickinson Wright, Dan served as an officer in Canada's foreign ministry and he was the Managing Director of the Canada-United States Law Institute. Dan also was a visiting professor of law at Case Western Reserve University School of Law and was a legal adviser to the US Department of Homeland Security and the US Coast Guard.



Ambassador David Wilkins, Partner, Nelson Mullins Riley & Scarborough LLP

Ambassador David Wilkins is a partner at Nelson Mullins Riley & Scarborough LLP and chairs the Public Policy and International Law practice group with a special focus on U.S.- Canada interests. He proudly served as U.S. ambassador to Canada from June 2005 to January 2009, appointed by President George W. Bush. Since returning home from Canada, Ambassador Wilkins spent six years chairing the Clemson University Board of Trustees and remains an active member of that board. He also sits on the boards of Porter Airlines, Mattamy Homes and Resolute Forest Products. In 2010, then South Carolina's Governor-elect Nikki Haley tapped Wilkins to chair her government transition team. First elected in 1980, Ambassador Wilkins served 25 years in the South Carolina House of Representatives. He was elected speaker in 1994 – a position he held for 11 years until he resigned for his ambassadorship post. He is the recipient of numerous awards including the state's highest honor, the Order of the Palmetto.

Alan Bersin, Former Assistant Secretary, Department of Homeland Security

Alan Bersin served as Assistant Secretary for International Affairs and Chief Diplomatic Officer for the U.S. Department of Homeland Security (DHS) Office of Policy. In those capacities, Bersin oversaw DHS's international engagement, served as the principal advisor to the Secretary on all matters pertaining to international affairs, and was responsible for leading the Department's strategic planning and policy formulation functions. Previously, Mr. Bersin served as Commissioner of U.S. Customs and Border Protection where he oversaw the operations of CBP's work force and managed an operating budget of more than \$11 million geared to protecting the nation's borders from all threats while expediting lawful trade and travel. Prior to this service, he was appointed by President Bill Clinton as the United States Attorney for the Southern District of California. Mr. Bersin served as U.S. Attorney for nearly five years and as the Attorney General's Southwest Border Representative responsible for coordinating federal law enforcement from South Texas to Southern California. Mr. Bersin is now an Inaugural Fellow at Harvard's Kennedy School, Belfer Center for Science and International Affairs.



John Ossowski, President, Canada Border Services Agency (CBSA)

John Ossowski was appointed President of the Canada Border Services Agency on December 7, 2016.

Prior to this appointment, John was Deputy Commissioner of the Canada Revenue Agency from July 2015 to December 2016. He has also held senior positions as Associate Deputy Minister of Public Safety Canada and also as Assistant Secretary, International Affairs, Security and Justice Sector, at the Treasury Board Secretariat (TBS). Before joining CSEC, John was Assistant Director, Government Relationships and Communications at the Financial Transactions and Reports Analysis Centre of Canada, which is Canada's financial intelligence unit. The USRC's mission is to educate, advocate and promote better tools for assessing and communicating building performance in natural disasters, and provide data to make better-informed decisions on owning, renting, leasing and insuring properties, so that market forces will drive the building design, and procurement process toward more resilient building design.

Vicki Christiansen, Interim Chief, U.S. Forest Service

Prior to Vicki's appointment as interim Chief of the USFS, she was Deputy Chief for State and Private Forestry where she had oversight of Fire and Aviation Management, Tribal Relations, Forest Health Protection, Cooperative Forestry, Grey Towers and Conservation Education. She joined the Forest Service in 2010 as the Deputy Director of Fire and Aviation Management. A dedicated champion for Alberta workers and Alberta business, Deron Bilous was sworn in as Minister of Economic Development and Trade on October 22, 2015. Prior to this, he served as Minister of Municipal Affairs and as Minister of Service Alberta.

Steve Metruck, Executive Director, Port of Seattle

Metruck brings 34 years of executive experience in maritime, security and financial leadership to his new role. Most recently, Metruck was Commander of the Mid-Atlantic Region, overseeing 3,600 military and civilian personnel, and before that, responsibility for planning and execution of the \$10 billion U.S. Coast Guard budget. Before his congressional service, Bruce Agnew was elected to two terms on the Snohomish County Council, and served as President of the Puget Sound Regional Council in 1985. Lyle was one of the first members in the newly formed Saskatchewan Party and was elected to the Legislative Assembly as the MLA for Thunder Creek in 1999.





Strengthening Innovation Ecosystems

Federal agencies and state governments make significant investments in the research and development of energy technologies to address critical National mission needs. There remains at this time however, significant unrealized commercial potential from these investments due to the "valley of death" that exists between a research prototype and a commercialized product. New coordinated regional public-private partnerships are needed to bridge the valley of death and accelerate the development and deployment of these energy innovations.

The Northwest Energy Innovation Alliance (NEIA) is a consortium that has been formed to address this challenge. The NEIA marshals the Northwest (NW) Region's innovation capabilities, resources, markets and opportunities to accelerate the transition of energy technologies to increase U.S. prosperity, competitiveness and job creation. The NEIA consists of member organizations from five NW states (AK, ID, OR, MT, WA) representing strong regional energy research, technology, business, financial and educational assets. It aims to develop a globally competitive energy industry sector in the Northwest

- ... that draws upon energy-focused R&D from regional institutions
- ... and is globally recognized as one of the sought-out locations
- ... for energy companies, professionals and policy makers to locate.

In short, the NEIA aspires to make the NW region an energy technology peer to California and New York.

The NEIA drives energy innovation through coordination of its members' capabilities and programs that span the energy technology lifecycle - from research and development to prototyping, technology validation, pilot projects, and commercial demonstrations. Alliance members' efforts will be aligned along a common Innovation Value Chain for transforming ideas and early stage prototypes into commercial outputs. 



WELCOME TO SPOKANE AND THE INLAND EMPIRE!



BNSF has been serving Spokane and Northern Idaho for more than 100 years. We're proud of our role in helping the region's agriculture, timber and other industries grow in today's global economy. We link them to domestic and international markets, and we support them by delivering materials vital to their operations.

In addition, BNSF helps deliver a wide variety of consumer products to retailers and businesses, including packaged goods, clothes, appliances, electronics, and automobiles.

Idaho is also home to BNSF's refueling facility at Hauser. Approximately 29 trains are serviced daily, with locomotives

receiving fuel, traction sand, lube oil and water in a turn-around time of 30 to 45 minutes per train. This quick-stop process enables trains to more efficiently transport freight critical to local, national and international customers and consumers. In addition to generating hundreds of jobs, from initial construction to operations, the Hauser fueling facility has raised the bar in environmental protection. BNSF operates the 24-hour facility with the highest commitment to environmentally safe and efficient operations.

Supporting BNSF's rail network in Idaho are more than 330 dedicated men and women who earn a combined payroll of nearly \$25 million. With more than 500 BNSF employees throughout the entire North Idaho-Spokane Valley area, our employees and their families represent a substantial segment of the regional economy.

Global Economy - U.S. and global economies rely on rail, and BNSF is a vital link in the global supply chain. We enable our customers to participate in a wide range of markets in North America and around the world.

Providing Needed Capacity - We serve a wide variety of shippers in nearly all U.S. industries, and we are working to provide consistent, reliable service today and to build our capacity to meet future demand. We're maintaining and improving our infrastructure, expanding capacity as needed and investing in our fleet of locomotives and railcars. We're also constantly investing to ensure our network will safely and efficiently meet freight transportation needs for decades to come.

Maintaining and Expanding Infrastructure for a Strong Network - Unlike other modes of transportation, U.S. railroads, including BNSF, own and maintain their rights of way. We fund the building, maintenance and repair of a private "rail highway" that delivers tremendous transportation value for our customers and the nation.

During the past decade we spent \$24 billion to improve our infrastructure. That includes maintaining a strong railroad through strategic investments in expanding track, yards and terminals; track renewal; technology; and new locomotives. BNSF has one of the newest locomotive fleets in the industry. Since 1999, we have acquired more than 2,700 high-horsepower locomotives. Because they are more fuel efficient, these new locomotives reduce our need to import expensive foreign oil and reduce greenhouse gas emissions.

Outlook for Future Capacity Growth - Increasing our rail capacity helps the U.S. compete more effectively and can reduce the environmental impact of freight transportation. The U.S. rail industry transports 40 percent of the nation's goods, in terms of distance and weight, for only 10 percent of the intercity freight revenue.

Since 1980 railroads have invested more than \$420 billion to maintain and improve their infrastructure. Over the same period, prices for rail transportation fell by more than 50 percent in real dollars adjusted for inflation, according to the Association of American Railroads (AAR). The U.S. Department of Transportation projects that demand for rail freight transportation, measured in tonnage, will increase 88 percent by 2035.

At BNSF, all of our investments in capital, asset utilization, people and technology help ensure we have the capacity to meet current and future freight transportation needs, while also improving our operating reliability and efficiency. The result is a stronger transportation infrastructure for our nation and a more reliable supply chain for our customers.*

RESILIENCY — BUILDING THE PATH TO A MORE SUSTAINABLE FUTURE

A Coalition of industry associations from across the Pacific Northwest have joined forces to build a more resilient future for the region. Operating across British Columbia, Alberta, Washington and Oregon, the Pacific Northwest Building Resilience Coalition (PNBRC) promotes the design and construction of resilient buildings better able to resist fire and water damage, and able to withstand extreme weather impacts and disasters such as earthquakes and wild fires.

There was no one issue or event that sparked the formation of the Coalition. Rather it was a growing awareness among some of the most experienced experts in the construction industry of the need for safer, healthier, and more energy efficient buildings for growing communities, while at the same time reducing vulnerabilities to natural disaster risks.

It is a daunting challenge. The demand for more affordable housing is rising at a time when land, building materials and construction costs are also rising. This has led to situations where choices of location, materials and construction methods could create risks that home owners or commercial property owners/managers are unprepared to bear.

Coalition members, mainly in the concrete, cement, masonry and reinforcing steel sectors, realized that consumers, policy makers, engineers, architects and community leaders needed to better understand the risks created by such choices.

The urgency of the need for better communication on these issues was soured by the devasting impacts of wild fires in British Columbia, Washington and Alberta that destroyed communities and claimed many lives. Extreme weather events across the region also laid bare the harsh realities that many homes and business establishments were unable to withstand or recover from the damage caused by floods and wind.

One of the first undertakings of the Coalition was a critical examination by Vancouver-based GLOBE Advisors of carbon sequestration in wood-based building products. This study examined the basis of industry claims that wood-based building products were less expensive, more environmentally friendly, and carbon neutral in their impacts compared to traditional concrete or steel structures. Based on peer-reviewed findings, the GLOBE study confirmed many of these claims were vastly overstated.

The Coalition has developed a suite of communications portals to make known the need for Building Better Buildings, and the importance of ensuring building codes and land use planning adequately addresses the need for resiliency in the face of changing climate realities.

Drawing upon the research efforts of the Portland Cement Association and the Concrete Sustainability Hub (CSHub) at the Massachusetts Institute of Technology (MIT), Coalition members are reaching out to industry and government leaders to develop policies and programs that will lead to more durable and sustainable homes, buildings, and infrastructure.

Partnerships have been formed with the U.S. National Ready Mixed Concrete Association, the Cement Association of Canada, and the U.S. Resiliency Council, each of whom are represented at this year's PNWER Summit.

The Summit's Disaster Resilience Symposium is a great opportunity to inform elected officials, legislators and others about the importance of resiliency planning. That is why the Coalition is pleased to sponsor a keynote address by Evan Reis, Executive Director and Co-Founder of the U.S. Resiliency Council.

The pioneering work of the Council has helped greatly to raise awareness of the need to rethink how we build our cities and towns to make them more resilient to hazards thought impossible only a decade ago. Over the next week do connect with delegates from the Coalition member associations and learn about how we can build a more resilient future for all.

PACIFIC NORTHWEST NATIONAL LABORATORY Uniting Innovation Around the Region



"Unity is strength... when there is teamwork and collaboration, wonderful things can be achieved." This quote from Mattie Stepanek, a young poet who died before he turned 14, sums up the importance of working together, sharing ideas and pursuing common goals. Pacific Northwest National Laboratory, managed and operated by Battelle for the U.S. Department of Energy, embraces this philosophy as it advances scientific discovery and solves some of the nation's toughest challenges in energy resiliency and national security.

Every day, our researchers work to invent efficient catalysts, develop sustainable biofuels, synthesize new materials for energy storage, strengthen

cybersecurity and deter illicit nuclear trafficking. At PNNL, we recognize that partnerships and collaborations, like those explored, enhanced and embraced at the annual Pacific NorthWest Economic Region Annual Summit, are a key ingredient to success. If we leverage the strengths and capabilities of our partners, we accomplish more together than our 4,500 scientists, engineers and support professionals could ever do alone. We collaborate with other national laboratories, academia and companies across the nation, around the world and right here in the Northwest.

For example, several new alliances and joint efforts in the region have been established in the past year. The first, with the University of Washington, is focused on materials science. The second, with Oregon Health & Science University, centers on precision medicine. Finally and most recently, with Washington State University, we formed the WSU-PNNL Institutes—a collection of three institutes that will advance discoveries and innovation in nuclear science, advanced grid and bioproducts.

We also work to advance science, technology, engineering and mathematics—or STEM—education and the public's access to it. As one of the world's premier laboratories for scientific discovery and technology solutions, PNNL is uniquely suited to engage and inspire the next generation of scientists and engineers.
