













#### OPERATIONS OF TRANSMISSION PIPELINES IN CANADA



- Contributed \$11.5 billion in GDP in 2015
  - \$5.1 billion to Alberta's GDP
- Expected to add \$175 billion to the GDP over the next 30 years
- Responsible for almost 34,000 jobs (FTE) across
  Canada; about \$2.9 billion in labour income





From 2010 through 2014, US crude pipeline mileage grew more than 12,000 miles, or 22 per cent
