Urban Air Policy Collaborative (UAPC) Description:

The Urban Air Policy Collaborative is an ongoing CAMI program which provides a structured network for state and local jurisdictions to discuss advanced air mobility issues, questions and strategies, and develop policies and best practices. It offers the benefits of a collective voice as communities work with industry and regulators to implement urban air mobility. CAMI offers 4-month long cohorts for small groups of jurisdictions to learn about urban air mobility through workshops, guest speakers and discussions around UAM topics at the local level. After participating in a UAPC cohort, graduates are invited to join the ongoing UAPC network.



UAPC Cohort 2021A Schedule & Pricing:

UAPC Cohort 2021A will meet from January - April 2021. There will be five group meetings during this time, with a schedule to be determined after the cohort participants are set. The cost for participation in the cohort is \$1000 per jurisdiction; up to three participants per jurisdiction are welcome at UAPC events. Should your jurisdiction wish to join the ongoing networking Collaborative after the cohort is complete, it will need to join CAMI as a member organization. The cohort fee can be applied to the membership dues for the first year.

UAPC Partnership Agreement:

We hope to welcome your jurisdiction as a member of the UAPC. It is a policy of UAPC that all members read and sign the UAPC Partnership Agreement. The purpose of this agreement is to ensure that members have mutual expectations as the their respective roles and responsibilities.

**URBAN AIR POLICY COLLABORATIVE
CODE OF CONDUCT**

The Urban Air Policy Collaborative (UAPC) community is made up of professionals committed to the UACP's mission of developing a policy framework for urban air mobility through the sharing of knowledge, discussion of issues, development of recommendations and collaboration with peers over a multi-month program of workshops, presentations and conversations.

Because we are a community of collaborators and believe that our civility and diversity is our strength, we have adopted the following code of conduct to promote and ensure an open, fair, welcoming, inclusive, and professional environment. This code of conduct applies equally to all collaboration members, including leaders, participants, and guests.

The UACP expects all members to:

- Collaborate openly – Collaboration is central to the success of the UAPC. If we don't work well together, we fail to achieve our mission. If we don't work openly together, we risk losing the trust of our colleagues and those who will benefit from our efforts. We expect members to

work transparently; involve other stakeholders; and not create private forms of communication that take away transparency or exclude other contributors and collaborators.

- Be welcoming – We strive to be a community that welcomes and supports people of all backgrounds and identities. This includes, but is not limited to, members of any race, ethnicity, culture, national origin, color, immigration status, social and economic class, educational level, sex, sexual orientation, gender identity and expression, age, size, family status, political belief, religion and mental and physical ability.
- Be considerate – Our work will be used by other people, and we in turn will depend on the work of others. Any decision we take will affect users and colleagues, and we should take those consequences into account when making decisions. Each of us must recognize that we don't have all the answers.
- Be respectful – Not all of us will agree all the time, but disagreement is no excuse for poor behavior and poor manners. We might all experience some frustration now and then, but we cannot allow that frustration to turn into a personal attack. Members of the community should be respectful when dealing with other contributors as well as with people outside of the community and with users of the resources developed by the UAPC.
- Address disagreements honestly and respectfully - Disagreements happen all the time. They are critical to robust dialog and innovation. Disagreement is a sign that an issue matters. The key is to disagree and discuss differing views constructively. UAPC participants should develop and test ideas impartially, without finding fault with the colleague proposing the idea. We dispute ideas by using reasoned argument, rather than through intimidation or ad hominem attack. Focus on helping to resolve issues and learning from mistakes.
