Water is essential to all life! It is economic. It is political. It brings out passion in people. Population growth, changing climate, increasing extreme weather events (storms, floods and droughts) and growing water scarcity are challenging our capacity to ensure that water does not become a limiting aspect of our future environmental, societal and economic prosperity.

Water also knows no political boundaries, albeit political jurisdictions within the same watersheds and basins often have differing institutional legislative and regulatory processes that impact how water is managed – who gets to use water, when and for what purpose. Too often water continues to be taken for granted or solutions are viewed from a too narrow perspective. This year’s Water Policy Group meetings will explore the opportunities that exist to begin to change the conversation around water – to build new collaborations that are focussed on workable solutions..

How are states, provinces and municipalities in the Pacific Northwest preparing for the extreme weather events, land use conflicts and threats to water supplies and water quality that are likely to result from global climate change? This session will feature researchers, legislators, municipal planners and other stakeholders who will discuss their efforts to prepare for an uncertain future. Discussion will focus on collaborative policy solutions to these challenges.

Columbia River Gorge, Bonneville Dam, and Insitu Unmanned Aircraft Policy Tour

A full-day tour that will bring participants an hour east of Portland through the beautiful Columbia River Gorge to visit the Bonneville Dam, as well as the opportunity to experience some of the natural beauty of the region.

The Columbia River Gorge is a spectacular river canyon, cutting the only sea level route through the Cascade Mountain Range. The Gorge is rich in cultural history, and remains home to 75,000 people, resource dependent communities, farms, and schools. Due to its geography as a key route through the Cascades, it remains a vital transportation and communication corridor where trains, barges, and highways support an interstate commerce as well as a source for wind and hydrologic power.

The first stop on the tour will be to the Bonneville Dam. Meeting the region's energy demands, transmission siting & storage needs, and the relationship between hydropower generation and salmon recovery, are just some of the topics for discussion.

Following the Dam, participants will be taken to Insitu's Eagle Point Production Facility. Insitu is a pioneer in the design, development, production and operation of high-performance, cost-effective unmanned aircraft systems. These technologies can be applied to intelligence, surveillance, and reconnaissance efforts in the defense sector, as well as the government and commercial industries, such as environmental monitoring, precision agriculture, search-and-rescue, disaster relief, and mining operation.

The tour will provide insight on what the unmanned technology industry offers in efficiency and safety for aerial data collection.

Please note: because of high security restrictions, participants must be registered in advance. There are no exceptions. Registration for this tour will close on June 20. A Visit Authorization form is required, along with a scanned color copy of your passport.
